

Reservation Fee Information

The Seller only reserves a puppy based on coat color, sex, and personality, no holds will be based on eye color. We do not guarantee eye color, as this may change as the puppy grows older. Buyer must sign the Reservation Fee Contract (before a puppy is reserved) in order to reserve the puppy of the Buyer's choice, otherwise the puppy will not be reserved and the Buyer will lose the reservation fee. If the Buyer sends in a reservation fee and doesn't send a signed copy of the Reservation Fee Contract within 24 hours the Buyer will forfeit their reservation fee & the puppy will not be reserved.

Pick of the Litter Reservation Fees

A reservation fee for the 1st or 2nd pick of the litter is determined on a case by case basis, depending on the due date of the dam. No reservation fees will be accepted before a confirmed pregnancy. Only a limited number of reservation fees (per litter) will be accepted before a litter is born (after confirmation of pregnancy) – due to unknown factors such as litter size, colors, sex, etc. Howlin' Wolf K9's reserves the right to have the 1st pick of every litter (1st & 2nd picks refer to the order of customer picks). This means that if you are 1st pick then you will be able to choose your puppy after Howlin' Wolf K9's decides if they want to keep a puppy and before any other potential adopters get to choose their puppy. Picks of the Litter are on a first come first serve basis (Howlin' Wolf K9's will let you know if you will have 1st or 2nd pick). If you are the first person to put a reservation fee down you will have the 1st customer pick. If you are putting a reservation fee down for coat color, you must specify at least two coat colors you prefer and are willing to accept into your family. If you are putting a reservation fee down for sex / gender, are you willing to accept the opposite sex?

I.e. what if you want a male, but there are only females left, would you take a female over a male?

Transferring Reservation Fee

Transferred reservation fees are only valid for other available puppies at the time of the original reservation, or the next planned / confirmed litter. Transferred reservation fees will receive the 3rd pick of the next litter, unless the 1st or 2nd picks are still available. This allows us to keep the amount of forfeited reservation fees down & so we do not have a long waiting list like other breeders. All reservation fees can only be transferred once, no other times.

For example: If you put a reservation fee originally on a puppy that was born in May and decided not to adopt that puppy, your reservation fee can only be transferred to another puppy that is available within any litter born in May, or the next planned / confirmed litter. If you don't choose another puppy that is available at that time, or from the next litter, you will forfeit your reservation fee.

Terms & Conditions

Buyer shall initial each statement certifying they've read and understand everything within the statement.

_____ **a.** Buyer acknowledges and agrees that all reservation fees are non-refundable and will not be returned/refunded in the case that the Buyer is no longer interested in a puppy / dog. Failure of the Buyer to complete this purchase would subject the Seller to lost opportunities to sell the dog to another person, and the retention of the reservation fee is meant to compensate the Seller for this possible loss.

_____ **b.** Buyer understands the purpose of the non-refundable reservation fee is to reserve the puppy for the Buyer, and the Seller will desist advertising the puppy once the non-refundable reservation fee and the signed Reservation Fee Contract are received.

_____ **c.** The reservation fee is directly applied to the final cost of the puppy / dog.

_____ **d.** Buyer understands that Howlin' Wolf K9's is reserving a puppy for the buyer until eight weeks of age. The Buyer agrees to pay the full amount of a puppy / dog by eight weeks of age (unless paying cash), otherwise the puppy will become available to other buyers. If paying the remaining balance with cash, then the full amount must be paid prior to the Buyer taking ownership of the puppy / dog. If the Buyer does not pay the remaining balance within three business days, the reservation fee will be forfeited and the puppy will be available to other buyers.

_____ **e.** The Buyer is responsible for all shipping and transportation costs, if applicable, and must be paid for before the puppy / dog is released from Howlin' Wolf K9's.

_____ **f.** Buyer acknowledges and agrees that the Seller reserves the right to void this transaction, and refund the reservation fee for any reason.

_____ **g.** If the puppy / dog were to die or otherwise be seriously injured before it goes to its new home, the Buyer's option will be to either:

- i. To transfer the reservation fee to another available puppy or future litter
- ii. To receive a refund of the reservation fee

_____ **h.** By signing the Reservation Fee Contract the Buyer agrees to the Pet Contract, even if he / she has not signed it yet.

_____ i. The Buyer has read and understands this contract and that ALL parts of this contract are a binding agreement with the Seller / Breeder. If the Buyer breaches any part of this agreement, the Seller is released from any obligation under this agreement. If either the Buyer or the Seller take legal action regarding this contract, action will be initiated in the county / state of the Seller's residence. Legal fees and court fees shall be the responsibility of the party found at fault.
